## **Mike Wigginton Retirement**



In the fall of 1976, I reported for duty as a Soil Scientist in Western Ohio. So began my 43+ year sojourn with **Dirt**, or as some prefer to call it, **Soil**. As the Grateful Dead song says; "Sometimes the light's all shining on me, other times I can barely see, lately it occurs to me, what a long strange trip it's been..."

"I'm a soil man", but now it's time to spend time pursuing a variety of other interests. My last day on the job will be November 1. I've had the privilege of doing interesting work with outstanding colleagues. I found a special niche the last nine years being the soils expert in Northwest Indiana and although I haven't got my head wrapped around this retirement thing yet, I trust I'll get used to it. Stay in touch and keep up the good work.

For those still reading and want to know "the rest of the story", I'll take this opportunity to recap my 43+ year sojourn...

In the Spring of 1971 after attending college for a year, I dropped out, lost my student deferment, moved out of my parents' house, broke up with my

high school girlfriend, drove a delivery truck for a year, received #45 in the 1972 selective service lottery, took a six week 6,000 mile road trip in a VW Bus, received my draft notice, and missed going to Vietnam because of a 4F classification. At that point I was ready to go back to school.

Books like "Silent Spring" and "A Sand County Almanac" guided my newfound interest in what I now like to call "Creation Care". After taking a bunch of Environmental Science, Agronomy and Civil Engineering courses, I graduated in 1975 from Ohio State University (it wasn't THE in those days). This city kid worked with the Ohio Environmental Protection Agency before being hired by the USDA Soil Conservation Service (SCS) to work as a Soil Scientist in Western Ohio where I made soil maps for six years in three Ohio counties.

In 1983, my wife Becky and I began overseeing a rural development project with remote area dwellers (Bushmen or San) in Botswana, Africa. Three years later, we left Africa with a 1 year old in tow, and as we would later find out, "two in the oven", travelling six weeks through Africa and the Middle East on our way back to the states.

Back in Ohio I worked at an Ohio State University research farm before we packed up our three kids and moved to Elkhart, Indiana where I worked at an Apple Orchard/Dairy farm as well as a couple summers with Pioneer Hybrid Seed Corn in Northern Indiana and Southern Michigan. While studying at the Mennonite Seminary we connected with folks working with Native Americans in South America and through that link spent the next eight years in Bolivia and Argentina, raising three kids and working with folks from several Native American tribes.

In 1996 we returned to the US. I worked with Michigan State University Extension in Southern Michigan before once again being offered a Soil Scientist job with the then re-named USDA Natural Resources Conservation Service (NRCS), the same agency I had left 14 years earlier.

Over the last 23 years I have worked several different NRCS soil scientist jobs as well as doing private soil consulting for the last 19 years. In 2010 after six months as the State Soil Scientist in Ohio, I decided I didn't like being an administrator and decided to be "downwardly mobile" and return to Indiana as Resource Soil Scientist in Lafayette, Indiana. Since then I have been kept busy helping people find and interpret the soils information they need.

The 68th session of the United Nations General Assembly designated 2015 as a soils celebration to increase understanding of the importance of soil for food security and essential ecosystem functions, the same path I have pursued since the 1970's. I plan to continue that work now, perhaps in a different capacity. NRCS and the nations' producers have a challenge promoting responsible land management, but I hope we will all find our way as strong advocates for sustainable and resilient soils.

#### IOWPA, IRSS, and the IAPSC

The early days of the IAPSC found most of the membership consisting of SCS soil scientists. This has changed over the years largely due to the completion of the accelerated soil survey program and the reduction in soil survey staff through retirement and reassignment. The IRSS has taken over the soil scientist certification program from the IAPSC. And the IAPSC has continued to exist to cover the subjects not allowed, or covered, by the soil scientist registration legislation. Largely ... our IAPSC meetings give the members needing ECUs a chance to earn those credits for IRSS certification, but it also allows the retired members a chance to connect and visit with colleagues twice a year. The IAPSC board members have long been aware of IAPSC/IRSS/IOWPA members who were also wanting to attend the IOWPA meetings too and the board has made efforts to schedule the IAPSC meetings in a fashion where this is possible whenever it could be worked out. We did a trial meeting in conjunction with IOWPA in 2019 and voted to do the combined meeting again in 2020. The vote for the combined meeting won by the slimmest of margins reflecting a few members over half wanting to attend the IOWPA meeting and the other half not wanting to attend at all. The cost of attending the IOWPA meeting being a big factor for those not wanting to attend. Most are not willing to spend \$100.00 for the one-day meeting. Subject material of the IOWPA meeting is another factor. Soil scientists who are retired or are not planning to do septic system onsites in the future have very little interest in septic system design and installation. I don't think having the combined meeting is a good thing for the entire membership of the IAPSC and we should not do it for 2021.
